The mentorship program needs to be re-started, however, and more action needed for Heritage Alerts /Heritage in danger, across the country – especially – though not solely, for 20th century, industrial and archaeological heritage. Of course, having adequate funds is crucial for any organization – and we welcome suggestions from the entire membership for on this matters.

ICOMOS India, re-established in its present form as COMOS India/ ICOMOS India in 2012, has over 320 members and institutions affiliated with it. The membership, across the zones, have consistently engaged with local, regional, national and international issues, and had a positive impact on heritage related matters in our 11 years of existence. Furthermore, ICOMOS India has increased its strength in various International Scientific Committees (ISCs), with several members holding elected positions as office bearers of their ISCs.

Even as 2024 marks 60 years of the Venice Charter, it will also see UNESCO's World Heritage Committee meet in New Delhi from 21-31 July. ICOMOS India will use the opportunity to participate in some official Side Events in Delhi, and simultaneously, hold exhibitions, workshops and walks in other parts of the country for the nation's citizens and heritage professionals alike.

To conclude, on the occasion of the Annual General Meeting, to be held in hybrid mode (in-person and online) on 29th June 2024, I wish to thank the Executive Committee, NSC Counsellor & Co-Counsellor, NSC Coordinators, Co-Coordinators, Scientific Council and Steering Committee members, Working Group focal and co-focal points, EPWG reps and the full ICOMOS India membership as we research, document, practice, teach, take action, and formulate policies for the protection, conservation and management of monuments, sites, habitat, biosphere and intangible heritage of the country and the world.

ABOUT COMOS

Council on Monuments & Sites (COMOS), a non-government organisation, is registered under 'the Societies Registration Act of 1860'. It is acknowledged as the National Committee of International Council on Monuments and Sites (ICOMOS) in India. The Society provides a platform for multidisciplinary experts to dialogue, develop and advocate for appropriate mechanisms, policies, frameworks relating to India's diverse heritage. It strives to establish good benchmarks of professionalism. This organisation is linked at the regional and international level with complementary ICOMOS committees and presents the Indian viewpoints that are rooted in specificities of our context, whilst gaining from international experiences. The primary aim and objects of the Society are for the benefit of the general public, as outlined below:

- Conservation, Protection, Rehanilitation and Enhancement of historical monuments, groups of buildings and sites on the national level.
- **2** Forum for Discussion and Exchange on matters of principle, and of technical, legal and administrative practice, affecting the conservation, restoration, rehabilitation and enhancement of monuments, sites and groups of buildings and historic landscapes.
- to promote research in specific themes related to the conservation, rehabilitation and enhancement of cultural heritage sites and disseminate the research to the general public.
- On World Heritage Matters, advise the 11 Government on nomination, periodic monitoring, including the conservation and management frameworks for World Heritage Sites.
- Regional Cooperation within the SAARC territories to promote greater understanding and regional exchange in the heritage field and to guarantee the generational renewal of all heritage professionals in the region.
- 6 Advisory Role to various Government institutions on policy matters in the field of heritage conservation.
- Awareness and Capacity Building for Young Professionals to facilitate, through its expert members, capacity building and professional training programmes.

- Organise Seminars, Conferences, Discussions and Exhibitions at the regional and national level to discuss heritage issues relevant to the Society's mandate.
- Heritage Education to promote a better understanding of the country's diverse multicultural heritage sites among the university and school children through regular awareness workshops and programmes.
- Establish National Scientific Committees 1 (Promote Traditional Building Crafts Skills to document traditional building crafts skills and knowledge systems as well as promote and preserve such skills through the organization of regular workshops, training programmes.
 - Community-based Partnership with Village Bodies and Institutions at the rural level in developing capacities of community based village bodies and institutions to manage, preserve, rehabilitate and enhance their heritage by providing access to technical expertise and resources. It shall serve to mainstream heritage concerns at the village level with decision making bodies at the district, state and central administration.
 - 12 Collaboration with Urban Civic bodies and Administration at the Urban level, the Society will work with municipalities and urban governance in promoting the preservation, rehabilitation and enhancement of historic centres and monuments by providing technical expertise. It shall work closely with urban civic bodies and administration as well as communities living in and around historic centres on issues of urban heritage conservation.



These events spanned both physical and virtual realms, as well as hybrid formats, drawing significant participation from both members and non-members. Activities included the Annual General Meeting of 2023, international and national webinars, panel discussions, publication launches, heritage walks, and numerous other initiatives.

Membership 2024



ICOMOS India is a membership based organization, with the membership process being an integral part of its functioning. Every year we are privileged to maintain our connection with the existing members who renew their membership and at the same time, welcome new members into our fold. The shared enthusiasm of both our longstanding and new members, to contribute to the vision of ICOMOS India is what propels us forward on our journey.

The Membership process for 2024 commenced in September 2023 and unfolded in three cycles, each lasting a month, ending in January 2024. The details of the 1st, 2nd and 3rd cycle of membership are as follows:

The results were announced during the ICOMOS India Annual General Meeting (AGM) held on 24th June, 2023 and the details of the Newly elected Executive Committee have been mentioned at the beginning of this section.

Executive Committee Meetings



The annual calendar 2023-2024 saw four Executive Committee meetings being held in online and hybrid mode.

- 1. ExCom 17 21st April 2023 Online
- 2. ExCom Handover Meeting 25th June 2023 Hybrid
- 3. ExCom 1 11th July 2023 Online
- 4. ExCom 2 2nd January 2024 Online

The first was the 17th Executive Committee Members Meeting (ExCom 17), which was held on 21st April 2023 over the zoom platform, with the ExCom members and the Secretariat Staff in attendance. This also happened to be the last meeting of the former ExCom (2020-2023). The second meeting was the handover meeting which took place on 25th June 2023, in hybrid mode for which three of the former ExCom members and nine of the newly elected members, joined in person from the MCR HRD Institute of Telangana, Hyderabad, while the newly elected Treasurer, former East Zone Representative and Secretariat Staff joined remotely via Zoom. The next meeting, ExCom 1, which was the first meeting of the newly formed Executive Committee was held on 11th July 2023 in online mode on the Zoom platform. During this meeting, for the nomination of the Institutional Member, within the ExCom, a draw of lots was conducted from among the voting institutional members namely, R. V. College of Architecture (RVCA) and Faculty of Architecture and Planning Dr APJ Abdul Kalam Technical University (FoAP AKTU). CEPT being the third voting member and ExCom member for the last term (2020-2023) was not included within this draw. FoAP AKTU won the draw. Dr. Vandana Sehgal was nominated as the

FoAP AKTU (Institutional Member) representative on the Executive Committee. ExCom 2 took place on 2nd January 2024 through online mode over the zoom platform with the executive members and secretariat staff in attendance.

Annual General Meeting 2023

ICOMOS India's Annual General Meeting was held on 24th June 2023 from 10:30 am to 3:30 pm, at MCR HRD Institute of Telangana, Hyderabad. Held in hybrid mode, through the zoom platform, it saw several attendees from across our membership joining us for the event. The quorum was successfully achieved with a total of 179 members in attendance (both online and offline), among which 93 were voting members.

The AGM of 2023 proved to be a resounding success, bringing together members both in person and online to engage in fruitful discussions. During the event, participants reflected on the strides ICOMOS India has taken in the realm of conservation and preservation of heritage and culture. Additionally, they collaborated to chart a course towards a more proactive and action-oriented approach for the future.

Reconstitution of Standing Committee for Heritage @ Risk

IDMS Events 2023

International Day of Monuments and Sites is held annually on 18th April. Each year ICOMOS

International proposes a theme. The theme for IDMS 2023 was "Heritage Changes". To celebrate IDMS 2023, ICOMOS India organized several events, which are as follows:

Apublication on the proceedings of East Zone and NSC HTV 2020 Webinar Series on Resilient and Sustainable Development of Historic Areas and Precincts: Focus West Bengal, was launched on 18th April 2023 as part of the World Heritage Day Celebrations held by the West Bengal Heritage Commission at Kolkata.

North Zone ICOMOS India celebrated the World Heritage Day by collaborating with SPA Delhi by holding a seminar (hybrid mode) on "Intergenerational dialogues on Cultural approaches", keeping in view the theme for the year "Heritage Changes".

North Zone, ICOMOS India in collaboration with Shahjahanabadi Foundation and Heritage Quest conducted a heritage walk, 'A Trail around the Markers in Delhi during the Siege of the Capital in 1857', on 23rd April 2023. The walk was led by Abhishek Jain, and highlighted the cultural significance of Kashmiri Gate of the historic Shahjahanabad wall and the heritage around it in relation to the 1857 siege of Delhi by the East India company.

NSC SBH organized an online discussion on 25th April 2023 on the Danish Settlements of Serampore and Tranquebar to celebrate World Heritage Day 2023. Shristina Shrestha, Conservation Architect spoke on Reviving Serampore, Indo-Danish Heritage and Akshaya J, Conservation Architect presented on Syncretic qualities in the built form of Tranquebar.

Appointments

1. Appointment of Research Intern

A call for applications for the post of Research Intern at the ICOMOS India Secretariat Office was sent out in October 2023 The Executive Board of ICOMOS India selected Ms. Akanksha Malik Parashar for the same. Ms. Parashar - a post-graduate in Archaeology with experience of working as an intern at National Museum, Delhi and freelancing as a heritage walk leader - commenced work at the Secretariat from 26th December 2023. Ms. Simran Deshpande, Research Assistant, Secretariat Office, ICOMOS India, who joined as a Research Intern in December 2021, served her tenure with us till May 2023. We take this opportunity to thank Ms. Simran Deshpande, for her invaluable support and dedication to ICOMOS India

2. Appointment of NSC Counselor and NSC Co-Counselor

The term of the NSC Counselor, Prof. Dr. Arun Menon concluded in August 2023. A call for applications for the post of NSC Counselor was sent out in September 2023. The ExCom nominated Dr. Venugopal B. as the NSC Counselor, and Dr. Mrinalini Atrey as the NSC Co-Counsellor. They both took charge from 1st February 2024 with a tenure of two years. We welcome the new NSC Counselor, Dr. Venugopal B. and NSC Co-Counselor, Dr. Mrinalini Atrey and look forward to the NSC's working with them. We also take this opportunity to thank Prof. Dr. Arun Menon, for his invaluable support and dedication to ICOMOS India during her tenure.

3. Appointment of Co-Focal Point of SDG

Ms. Shinjini Saha has been appointed as the Co-Focal point of the Sustainable Development Goals Working Group, and took office in March 2024. Ms. Saha is an urban designer, researcher and strategist with nearly 5 years of professional experience. She holds a Masters in Urban Design from SPA Delhi. Currently as a Project Officer at the National institute of Urban Affairs (NIUA), under the UrbanShift Country Project, she drives the adoption on nature-positive, low-emission, and climate-resilient solutions.

None Zone, ICOMOS India, celebrated the World Heritage Day by collaborating with the School of Planning and Architecture, New Delhi by holding a seminar in hybrid mode on "Intergenerational Dialogues on Cultural Approaches", keeping in view the theme for this year's World Heritage Day 2023, "Heritage Changes".

The session was opened by Debasish Nayak, Manish Chakraborty, Ashish Trambadia, Ravi Gundu Rao and Smita Datta Makhija offering their perspectives on the topic. The discourse was centered on Heritage methodologies for climate resilient sustainable development in two sessions. The first session focused on 'Traditional Knowledge and Climate Resilience'. Dr Rohit Jigyasu, Shalini Dasgupta and Divay Gupta cited examples of heritage buildings which provide thermal comfort and energy efficiency thereby impacting the causes for climate change. 

23 April 2023: Heritage Walk - A Trail around the Markers in Delhi during the Siege of the Capital in 1857

North Zone, ICOMOS India, in collaboration with NSC Intangible Cultural Heritage, Shahjahanabadi Foundation and Heritage Quest conducted a heritage walk lead by Abhishek Jain, to highlight the cultural significance of Kashmiri gate of the historic Shahjahanabad wall and the heritage around it in relation to 1857 siege of Delhi by East India company.

The walk commenced from Kashmiri gate to Nicholson cemetery and ended at Mutiny Memorial. The sensitivity of making interventions in historic context was highlighted by incongruous development initiatives like the metro station which abuts the Kashmiri Gate, a national level listed monument. The walk also proved to be an opportunity for young professionals to interact with ICOMOS India members to understand the complexities of making decisions for transformation of fragile historic urban landscapes.

29 July & 12 August 2023: Hydrology and Heritage: Himalayan River Ecology: Sustenance and Responsible Intervention


ICOMOS India North Zone, held a webinar which was basically a dialogue, keeping in view the flooding of heritage areas in the river Yamuna basin, on the Himalayan River ecology's relationship with the historic settlements and the current reasons for the devastating flooding in North India.


The panelists acknowledged the need to understand the hydrological heritage resources from the past and their relevance in the eco centric planning of historic cities today.

Experts Suruchi Shah, Vikram Soni, Prof Meenakshi Dhote voiced concern about the incompatible interventions with respect to the river's inherent nature and the aspects that need to be integrated in the planning process, stressing on maintaining the health of flood plains to prevent contamination.

Jagan Shah and Madhav Raman spoke about the Yamuna floodplain and the measures already tabled in the past which have not been implemented. In this session the Himalayan ecology parameters were examined in a scientific manner through the historic and present times perspective to prevent disasters due to flash flooding, the private and government initiatives were examined to list out parameters for further work on the topic.





18 April 2023: Launch of ICOMOS India E-Publication on 'Resilient and Sustainable Development of Historic Precincts and Areas'

The publication, "Resilient Sustainable and Development of Historic Areas and Precincts: Focus West Bengal" brings together transcripts, keynote addresses and panel discussions, along with papers on the case studies presented in the seven webinars organized by the East Zone and NSC HTV in collaboration with the Emerging Professionals Working Group (EPWG) from August to December 2020. The members of the core organizing and the editorial team led by Dr. Sanghamitra Basu were Ms. Ananya Bhattacharya, Dr. Arjun Mukerji, Ms. Kamalika Bose, Ms. Puja Bhowmik, Dr. Sukanya Mitra, and Mr. Sukrit Sen.

The webinars covered Concepts, Frameworks, Needs and Experiences of Historic Precincts and Areas; Heritage Economics, Legal Tools, and Management Mechanisms for Historic Precincts and Areas; Engaging Communities for Sustainability and Resilience; Safeguarding Intangible Cultural Heritage; Resilience to Disaster, Pandemic, and Climate Change. It was felt that a wider dissemination of the rich discourse was desirable, and an editorial team worked on developing a publication. The compilation is based on transcripts of digital video recordings of keynote addresses and panel discussions, along with the case studies and

articles. It is expected to contribute towards various policies, programmes, and activities that need to be formulated and adopted to enable historic precincts and areas of West Bengal as well as other places and people. We thank all the keynote speakers, case study presenters, panel discussants for their support in compiling the publication.

The publication was launched in a commemorative event hosted by the West Bengal Heritage Commission on World Heritage Day (April 18,2023) at Nandan III Hall in Kolkata. In a presentation titled 'Integration of Built, Natural and Intangible Heritage of West Bengal', Dr. Sanghamitra Basu , Dr. Arjun Mukerji and Ms. Kamalika Basu shared case studies, insights and recommendations from the publication. Dignitaries present included Chairpersons from WBHC, West Bengal BioDiversity Board, West Bengal Pollution Control Board, British Council Regional Director (East and North East), eminent author Mr. Amit Chaudhury, Regional Convenor INTACH, and Secretary ICOMOS India. A physical meeting was convened at Kolkata's "RED BARI," an example of the adaptive reuse of a heritage building. The members often meet online and have taken up specific activities connecting the State Heritage Commission in West Bengal. Specific tasks are mentioned in the letter sent to the West Bengal Heritage Commission.

- Riverfront Development Strategy for Kolkata: Develop a comprehensive whitepaper integrating heritage conservation principles with modern development practices considering the "urban Transformation" process.
- 2. Heritage Health Report and Awareness Programs: Create a "Heritage Health Report" mechanism for listed and non-listed structures at the district level. Organize periodic Heritage Awareness Programs to engage and educate communities about the importance of heritage preservation.
- 3. Comprehensive Documentation of Spatial Attributes associated with Durga puja: Listing of "Bonedi Bari-er Pujo": Seek support from WBHC to work on a comprehensive documentation of spaces and context and, as an initiation of that, look at the Durga puja historically organized by the Bengali family as a part of their cultural tradition

within their pristine built spaces across the state and associated built heritage.

A working group was constituted to discuss these initiatives, led by Ms. Ananya Bhattacharya and Mr. Kamal Banerjee, supported by Ms. Mukul Agarwal, Prof. Akhil Ranjan Sarkar, and Mr. Sandipan Chatterjee.


April to August 2023: Riverscape Series







10 November 2023: Webinar on Brajwali -A Special Literary Language





Abdul Motin Chowdhury discussed the history, utility, and service overview, Er Nilotpal Kalita spoke on the exploration of technology, design, and architectural importance and Dr. Rima Hooja emphasized on the global linkage that marked key insights.

Er. Simanta Tamuli discussed the bridge's uniqueness, social impact, and potential World Heritage Site status. Concerns about the bridge's reparability were addressed, proposing a comprehensive plan for aged steel bridges.





These captivating rituals have been meticulously explored by distinguished experts in the field, including Dr. Madeline Yvonne Tham, Ar. Aiban S Mawkhroh, and Professor Emeritus Dennis Royse. 

International experts, including Professor Singh and Dr. Sanjib Kumar Borkakoty, provided valuable insights. Professor Singh stressed the intricate relationship between nature and culture, advocating for education that integrates deeply rooted traditions into the cultural framework. Dr. Borkakoty offered recommendations for the living root bridge's UNESCO submission, emphasizing comprehensive preparation and economic implications.

The collective aspiration is for Jingkieng Jri's designation as a World Heritage Site, with a commitment to assisting the Government of Meghalaya. The international experts in the North East Zone pledged continuous support, reflecting a shared vision for the preservation and recognition of the cultural landscape. ANNUAL GENERAL MEETING 2023

MOM Report by Ar. Madhu Vottery, Rapporteur & NSC CT Coordinator

ICOMOS India's Annual General Meeting was held on 24th June 2023 from 10:30 am to 3:30 pm, at MCR HRD Institute of Telangana, Hyderabad. Held in hybrid mode, through the zoom platform, it saw several attendees from across our membership joining us for the event. The quorum was successfully achieved with a total of 179 members in attendance (both online and offline), among which 93 were voting members.

The programme was inaugurated by lighting of the lamp, by the dignitaries who were gracing the occasion. These included IAS Shri. Sandeep Sultania, Principal Secretary, YAT&C, Shri B. Narayana, Deputy Director, Department of Heritage Telangana, Shri M. Vedakumar, Chairman, Deccan Heritage Academy Trust, Shri Ratish Nanda, CEO Aga Khan Trust for Culture, Dr Navin Piplani, President, ICOMOS India and Ar. GSV Suryanarayana Murthy, South Zone Representative, ICOMOS India.

Sri Sultania extended his gratitude and thanked ICOMOS India for choosing Hyderabad as a venue for the AGM 2023 as well as for their efforts in the nomination of Ramappa Temple as a UNESCO World Heritage Site. He went on to brief the gathering about the Master Plan of the area around the WHS and the Government of India's involvement there. He also mentioned about the efforts taken by the Telangana State Government and Aga Khan Trust for Culture, in restoring heritage Sites, the likes of Qutb Shahi Tombs.

The South Zone Representative, Ar. **GSV** Suryanarayana Murthy, thereafter, invited Dr Navin Piplani, the outgoing President to present the Welcome Address. Dr Piplani spoke about the efforts taken by ICOMOS India members as a part of the different NSC's and ISC's for research exploration and publications. He stressed upon ICOMOS India's role as an advisory body to the government, similar to that of ICOM and ICCROM. Taking this opportunity, he thanked the Executive Committee 2020-2023 for their efforts by highlighting how, even during the pandemic the ExCom planned, organized and executed various scholarly events virtually. The South Zone Representative, Ar. GSV Suryanarayana Murthy then thanked Dr. Piplani and that brought the Inaugural Session of the AGM to a close.

Outgoing Secretary, Ar. Shalini Dasgupta, then took the stage and the approval of agenda, as well as presenting the minutes of AGM 2022 was done by her. Thereafter, the AGM 2023 followed the due process of appointment of Chair of the meeting, Dr. Navin Piplani, outgoing President ICOMOS India and appointment of rapporteur - Ar. Madhu Vottery.

With the term of the Executive Committee coming to an end, elections were held in June 2023 and hence the outgoing Secretary, Ar. Shalini Dasgupta introduced the Election Officer, Ar. Kalpana Raghavendra and Returning Officer, Ar Xavier Benedict. Dr. Navin Piplani, outgoing President ICOMOS India, and Chair then presented the Annual Report, wherein he briefed the members about the activities and events organized by ICOMOS India. As outgoing President he thanked the EPWG and NSC's. The events as a part of Azadi ka Amrit Mahotsav and a road map for 25 years were also discussed by him. This was followed by Ar. Shalini Dasgupta, outgoing Secretary presenting the Secretariat Report (2022-2023). The outgoing Treasurer, Priyanka Singh, thereafter presented the Expenditure (2022-2023), Audited accounts, Budget (2023-2024) and appointment of the CA & Auditor for the financial year 2023-2024. This was followed by the six zonal Representatives giving updates on zonal activities. These included, Dr. Ananya Bhattacharya for the East zone, Ar. Poonam Trambadia for the West zone, Dr Smita Makhija for the North zone, Professor GSV Suryanarayana Murthy for the South zone, Ar. Nishant Upadhyay for the Central zone and Er. Dilip Chngkakoti for the North East zone. The NSC Counselor, Dr. Arun Menon, then presented the updates on NSCs and WGs activities. This was followed by the outgoing Vice President, Dr. Rima Hooja's address. The result of the elections for the Executive Committee 2023-2026 which were held in June 2023 & Introduction of the newly elected Executive Committee was announced by the election officer and returning officer.

Last, but not the least, the vote of thanks and closing remarks were given by outgoing Secretary, Ar. Shalini Dasgupta, and with this the AGM 2023 came to an end. The AGM 2023 was a successful event where members, in person and online, met and discussed the progress that ICOMOS India has made over the years

NSC HISTORIC TOWNS AND VILLAGES

February 2024: Comprehensive Study of Vernacular Architecture and Heritage Settlements in Punjab

ICOMOS India conducted an activity, 'Comprehensive Study of Vernacular Architecture and Heritage Settlements in Punjab' in collaboration with the University Institute of Architecture, Chandigarh University. Aligned with the ICOMOS India Training and Capacity Building program, the activity was proposed by Dr. Niyati Jigyasu, Coordinator of NSC Historic Cities, Towns, and Villages, and supported by Dr. Vaishali Latkar, NSC Education and Training. The documentation workshop was planned in 3 stages that involved pre-activity webinars followed by an on-site study, and a review session concluding with a postevent session. The participants included 30 students from Architecture and 5 from Media Studies. The workshop is the second in a series of collaborative training programs put forth by the NSC HCTV.

ICOMOS India conducted an activity, 'A comprehensive study of vernacular architecture and heritage settlements in Punjab' in collaboration with the University Institute of Architecture, Chandigarh University.

Aligned with the ICOMOS India Training and Capacity Building program, the activity has been proposed by Dr. Niyati Jigyasu, Coordinator of NSC Historic Cities, Towns, and Villages, and supported by Dr. Vaishali Latkar, NSC Education and Training. This activity aimed to explore the vernacular architecture and settlements with ecological and historic contexts. The documentation workshop was planned in 3 stages that involved pre-activity webinars followed by an on-site study, and a review session concluding with a postevent session. The pre-activity lectures were conducted by experts from ICOMOS India and CU, covering topics such as methodology for documentation of tangible-intangible heritage, as well as application of geospatial technology in heritage study. The on-site study was conducted in 4 days. The first day included a visit to the various heritage sites of the historic city of Amritsar. These include Heritage Street, Partition Museum, Jallianwala Bagh, Sri Harimandir Sahib, and Gobindgarh Fort. This was carried forward in the form of a cultural mapping exercise which was an interesting exercise on brainstorming for the students.

The second day involved understanding the history of the village and exploring the village through the lens of its organic settlement pattern, which encompasses not only its physical layout but also the intricate web of socio-cultural interactions within. This also needs to be connected to the larger ecosystem around.

The participants include 30 students from Architecture and 5 from Media Studies. The workshop also introduced students to contemporary documentation techniques such as photogrammetry and drone usage. The workshop concluded with a presentation of the student's final work to an audience comprising school children and community stakeholders.

The workshop seeks to increase the visibility of ICOMOS India and its activities among the younger generation. Second, in the series, the activity is in line with the one conducted by BRICK College of Architecture, Pune in 2021 and which is culminating in a handbook this year.

NSC SHARED BUILT HERITAGE

NSC SBH conducted two major events in the year, a discussion on Studying Danish Culture in the India context and a talk on how shared cultural heritage can build regional cooperation keeping Calcutta and Dhaka in mind. Both the events got a good response and helped fulfil a major aim of the NSC, which is to understand the nature of Shared Heritage in the Indian context. Apart from this the NSC conducted meetings amongst its members to keep in touch with each other. It is already collaborating with NSC 20 th century on a project to identify the shared built heritage of Kolkata in the 20 th century. We hope to hold an exhibition based on the outcomes of this project which will be a major event in the upcoming year.

25 April 2023: Studying Danish Culture in the Indian Context: A Discussion on the Danish Settlements of Serampore and Tranquebar

NSC SBH organized a discussion on the Danish Settlements of Serampore and Tranquebar on 25th April, 2023 to celebrate World Heritage Day over the zoom platform with 40 to 50 participants in attendance. Ms. Shristina Shrestha, Conservation Architect spoke on Reviving Serampore, Indo-Danish Heritage and Ms. Akshaya J., Conservation Architect on Syncretic qualities in the built form of Tranquebar.

The vast coastline and abundant supply of spices and wealth in India drew many European countries to establish links through maritime trade. Beginning with the Muslim intrusions in the early medieval period until the gaining of independence from British rule in 1947, there has been evidence of numerous cross-cultural discourses across the country as an effect of invasion, trade, and religion. This is the foundation of the multi-faceted culture of India that is witnessed today. Cultural expression is analogous to architectural expression, which originates from as early as the Indus Valley Civilization in India, where the architecture and inscriptions tell fragments about the history and daily life of its people. Similarly, the architecture of the invaders and traders symbolize the cross-cultural encounters between the foreign and the indigenous, as there is always an act of borrowing and sharing. This amalgamation has led to the emerging of new languages in architecture called "eclecticism" and "syncretism". Their mere occurrence in architecture is the expression and indication of a rich "shared heritage". Serampore and Tranquebar are two sites in India that have witnessed this cross-cultural exchange between the Indian and Danish populations and the architecture of both these places are replete with examples of such shared elements.

The first presentation was by Ms. Akshaya J. on Tranquebar. Tranquebar not only has a Danish connection but also a British one. Initially a Danish settlement it was sold to the British in 1845 for a small sum and hence the place has elements of Indian, Danish and British influence. Akshaya J. began by providing the historical background of Tranquebar. She then went on to explain the socio-cultural life of Tranquebar during the glory days of the Danes including their style of government, religion, language, cuisine, textiles, music, dance etc. She mentioned that after the Tsunami of 2006 efforts were underway to restore the town. She then analyzed the layout of the settlement within the walled town. She mentions that Protestant Christianity had an impact on the Danish settlement. Akshaya then explained the interior spaces of everyday dwellings in the Tranquebar settlement such as the Danish churches, Tamil houses etc. and this provided an interesting contrast with Srishtina's presentation which was more about grand monuments. Akshaya explained the inner layout of a typical Tamil Hindu dwelling followed by a Muslim trader's house and the Governor's residence on King's Street. She showed how the climate, local materials and religion impacted the interior designs of each of these buildings. The flooring and walls of the Danish buildings showed how they adapted to the local climate and conditions. She concluded that the Danes were primarily traders and so they did not really try to build grand buildings like the British did.

Ms. Srishtina Sreshtha spoke about documenting and proposing the repair and reuse of the Goswami Rajbari in Serampore. Srishtina emphasized how the river Hooghly contributed to the trading opportunities provided to the different European powers. She began with the geographical and historical background of Serampore. It was named Frederiksnagore after the king of Denmark in the 18th century. She went on to speak about the indigenous families of Serampore and how the Danes established themselves there. Srishtina then elaborated on the housing typologies of the area and their layout and materials used such as mud. The Danish Government House in Serampore was analyzed followed by the Goswami Rajbari which shows the presence of Danish as well as more indigenous/vernacular elements. Srishtina also

spoke about the river bank view of Serampore which showed European influence. Development of the railway link in 1854 also impacted the development of Serampore. The conservation and revival of the history of Serampore since the 2000s was also highlighted by Srishtina which was undertaken jointly by the Government of India and the National Museum of Denmark. St Olav Church, Government House and the Danish Tavern have been restored while the Goswami Rajbari is still to be conserved. 7 March 2024: Talk on "Building Regional Cooperation Through Shared Cultural Heritage of Kolkata and Dhaka"

NSC SBH in collaboration with ICOMOS India organized a talk entitled, "Building Regional Cooperation Through Shared Cultural Heritage of Kolkata and Dhaka" on 7th March, 2024 at 6.30 p.m, with 45 participants joining online over the zoom platform.


The talk began with a discussion of the shared geographical, morphological and etymological linkages between Dhaka (currently the capital of Bangladesh) which flourished during the Mughal period and Calcutta (currently the capital of West Bengal) which came up in the colonial period. The Riverine linkages, economic activities and the historical contexts of both cities were highlighted. Riverfront activity along the Buriganga and Hugli rivers were pointed out. Ghats such as Sadar ghat, Badamtali ghat, Balur ghat in Dhaka and the Hugli river ghats shared similar economic activities once upon a time. Despite the similar uses of the rivers, less activity is noticed along the Hugli river as compared to the Buriganga in the contemporary period. Now Calcutta has turned its back on the river but not Dhaka. This is a major point of difference between the two cities.

The speaker Ms. Kamalika Bose, a member of NSC SBH then went on to talk about the multi-ethnic character of the two cities. In Calcutta there was a grey town during the 18th and 19th centuries which acted as a buffer between the Black native town and the White colonial town where Armenians, Portuguese, Parsis, Chinese, Jews and other communities lived. In the case of Dhaka these communities settled on the city's fringes and could be identified by their nomenclatures—Armeniantala (Armenian settlement), Farasganj (French settlement) etc. The talk then went on to focus on the cities' historic neighborhoods and community linkages. Markets were at the core of the historic fabric and evolution of both the cities. The talk focused on trade-based river heritage project that the speaker had undertaken with students. She highlighted the past and present conditions of certain trades such as soap making, wooden objects making, sankhari bazar (shell making market) tobacconists etc. The culture-nature-water heritage linkages in Kumartuli in north Calcutta was particularly interesting. It is an area famous for idol making and the river plays a direct role in this since the raw materials like bamboo, clay etc are often transported via it. The idols are also immersed at the end of the festivals and this


completes a cyclical journey from the origin in the river and end in it. The tambaku wala or tobacconists on Armenian Street in Calcutta particularly showcases 20th century migration. The shared typologies and architectural linkages between Puran Dhaka (Old Dhaka) and Purono Kolkata (Old Calcutta) and their convergences formed the concluding section of an enriching presentation. WEBINAR 01 - SATURDAY, MAY 13, 2023, @18:00 IST, EAST ZONE

Rural Tourism Of Bengal, Lesser-Known Village Festivals

Dr. Madhura Dutta the Director at 'banglanatak dotcom' with leading international collaboration and research initiatives for over 20 years of global work experience including UNESCO.

The presentation was about 'Harnessing the power of

folk festivals for responsible Village Tourism'. It was also about empowering local cultural communities, creating multi-cultural awareness, and ensuring well-being of rural creative collectives in West Bengal.

2. Intangible Heritage Of Indigenous Odisha

Sri Jitu Misra, an archaeologist by training and a heritage enthusiast by heart, working in the areas of Immersive and cultural tourism, handloom intervention and sustainable crafts.

The intangible heritage of Indigenous Odisha with special reference to Bhima, the Mahabharata hero how he plays a central role as a fertility deity in the culture of Gonds, Kondhs and Bhatra tribes. The tribal festivals and rituals would be talked about.

Durga Puja: The Intangible Cultural Heritage Unesco

Ar. Sayantan Maitra Boka A Curator, Architect and Collaborative Artist Sayantan has explored in the realm of public art doing site specific interventions with LAYOUT Collective.

Durga Puja in Kolkata has always been a socioreligious celebration involving the masses. The UNESCO tag 'Intangible Cultural Heritage' has brought global attention to Durga Puja. The speaker presented a special glimpse of previous years' Durga Puja installations to experience the Durga Puja Art and temporary architecture of the festival and the process of transformation of the city. The speaker will give a glimpse of these festivals in his presentation and discuss the salient features of each. It will be an eye-opener to the rich traditions of the ethnic groups

in Assam.

3. Festivals At Shaktipithas Of Himachal Pradesh

Shaktipithas are venerated Hindu temples that symbolize our ancient cultural landscapes. The festivals and traditions followed in these shrines were the topic of discussion. The heritage of temples were discussed through festivals, annual celebrations and daily rituals, through which the significance of pilgrimage to these shrines is enhanced. Jirnodhar Practices Of Historic Ahmedabad : An Intersection

Between Tradition, Modernity And Authenticity

Yash Gupta is an Architect with Master's degree in Conservation and Regeneration from CEPT University.

The talk explored the sacred landscape of the Jain community in historic Ahmedabad, which comprises interconnected temples, monasteries, and religious institutions. The landscape has played a significant role in the city's cultural and economic development since its establishment in 1411. Central to this landscape are the Jirnodhar practices, which involve the renewal of Jain temples and serve as a medium for spiritual connection with the divine. These practices have resulted in multiple cycles of restoration and reconstruction of Jain temples, creating a dynamic and transformative sacred landscape with layers of historicity and meaning.

Mahashivratri - Association And Celebrations At Markanda Temple, Gadchiroli, Maharashtra

Located along the River Wainganga, the Markanda

Temple at Gadchiroli is dedicated to lord Shiva built between 9th to 12th Century A.D. The temple complex presently has 18 temples dedicated to lord Shiva. The talk is about the temple festival when the village transforms during these 10 days hosting various religious and recreational events. The association of the people with the site and surrounding is visible through the transformation during the festival of Mahashivaratri.

The Religious Landscape Of Parner & Shri Ram Janma Utsav Therein: Named after Rishi Parashar, Kasba Parner in Ahmednagar district of Maharashtra is unique. As a Shri Kshetra, it is a Prati Kashi of the Deccan, with several sacred sites and historic settlements like Takli Dhokeshwar, Devi Bhoyra and Siddheshwar Wadi. One such Maratha temple complex is the 250-year-old fortified Shri Ram Mandir, built by Sardar Parnerkar, Huzur Fadnavis of Indore State. The entire temple is adjacent to a historic Kund and is surrounded by high defensive walls that once housed a Wada and other ancillary structures. The religious celebrations and traditions therein are also being revived through current conservation efforts. The Ram Janma Utsav deserves a special mention here.

Shreeamey Phadnis is an Assistant Professor in the Dept. of Architectural Conservation at SCOA Pune. He is a co-founder of the Heritage Consultancy's Studio Gestalt'. Recording of the event is available here.

Dr. Satyanarayana Dyavanapalli, a well-known scholar, is working as Curator of Tribal Museums, Government of Telangana, India.

2. Women: A Celebration Of Kerala

Women centric festivals celebrated in Kerala has a strong root of traditional and social values. Myths, rituals, food and art forms related to these festivals and their significance in the current trends were also focused during the session.

Ar. Nandhini V is An emerging conservation architect

exploring her stream of interest, opportunities and passion.

20 May 2023: New Education and Management' for Responsible Conservation in India

NSC Theophilos, in collaboration with NSC Cultural Landscapes, NSC Education and Training, NSC LAFI with South Zone

A roundtable discussion was organized by NSC Theophilos in collaboration with NSC CL, NSC TC, NSC LAFI and South Zone, ICOMOS India on the theme of "New Education and Management for Responsible Conservation in India. It attempted to articulate the dimensions of operationalizing, that is - from Theory to Action through education with equal rights to all. It is expected that the approach may broaden the horizons of and lead to interdisciplinary methods in the new curriculum.

Prof. Nalini's session highlighted various aspects, which are as follows: - In the past we have encountered significant challenges within the existing management system, leading to chaos and unmanageable contexts. During a recent session, you learned that your new nomination has been sent to UNESCO as a natural site, but uncertainty surrounds its authenticity. This situation highlights the need for transformative change - a fresh approach to management and education. As we celebrate the 50th anniversary of the World Heritage Convention, the focus now shifts to the next 50 years. India must learn how to effectively manage its complex heritage resources and sites. This endeavor presents an opportunity for reflection and innovation, especially within the e-commerce sector. A new paradigm is essential to navigate this dynamic landscape and ensure sustainable stewardship of our cultural and natural heritage.

The roundtable was opened by ICOMOS India Secretary Shalini Dasgupta. President. Prof. Nalini M Thakur spoke about New Education for Conservation Education from a holistic and cultural perspective – An implemented Case. Prof. Vishakha Kawathekar discussed the New Education challenge to ensure sustainability and authenticity in management. President ICOMOS India - Navin Piplani spoke about Role and place of Traditional Knowledge and Systems in Conservation education. Prof. Rana P B Singh discussed Interpretation of "Indian Cultural Landscape" for conservation education. Ar. Surya Narayana Murthy spoke about Documentation, the range, contents, and

contents for conservation education. Prof. Vaishali Latkar discussed Traditional settlement research and its interface with planning. Prof. Jigna Desai presented the case - Planning Challenges on 'Real Historic city ground'- CEPT Ahmedabad Experience. Porf. Arun Menon spoke about the Traditional Engineering knowledge as an essential in New Education. The session was moderated by Prof. Lakshmi Priya, and assisted by Dr Monalisa Bhardwaj.

The series aimed to define a new philosophical base for conservation, emphasizing a holistic Indian perspective. Recognizing the uniqueness of Indian heritage, it advocated for different research, action, and knowledge management approaches. Encouraging an

interdisciplinary lens, the discussion delved into the meaning and significance of culture at various levels, emphasizing the historical interplay between nature and culture in shaping India's cultural landscape. Highlighting heritage as a living tradition, the series challenged the Western dominance in heritage studies and the limited scope of "authorized heritage." It aimed to develop new paradigms by fostering dialogue, exploring alternative methodologies, and engaging young professionals. Ultimately, the series envisioned India as a non-Western paradigm, contributing to a broader understanding of conservation on a global scale. The focus, key ideas and other aspects of this series have been elaborated below.

Focus:

- 1. Defining a new philosophical base for conservation with a holistic Indian perspective.
- Recognizing Indian heritage as a unique system requiring different approaches to research, action, and knowledge management.
- 3. Encouraging an interdisciplinary approach to understanding and managing heritage.

Key Ideas:

- Culture as a central concept: The discussion explores the meaning and significance of culture at various levels (micro and macro).
- Nature-culture connection: Professor Rana emphasizes the historical interplay between nature and culture in shaping India's cultural landscape.
- 3. Heritage as a living tradition: This perspective emphasizes continuity, transformation, and transmission of heritage to future generations.

Challenges:

- Western dominance in heritage studies: The traditional focus on Western methodologies and perspectives needs to be challenged.
- Limited scope of "authorized heritage": Expanding the definition of heritage beyond grand, prestigious sites to include marginalized voices and perspectives.

Looking Forward:

- Developing new paradigms: The webinar series aims to foster dialogue, explore alternative methodologies, and engage young professionals in shaping the future of heritage studies in India.
- India as a non-Western paradigm: The potential for India's unique heritage to contribute to a broader understanding of conservation on a global scale.

# **OVERVIEW OF ANNUAL ACCOUNTS:** FY 2023-24

### **Budget**

The Annual Budget for FY 2023-24 anticipated an income of Rs. 22,35,000 and expenditure of Rs. 41,80,680. The actual income was Rs. 13,15,801, this variation is attributed due to no funds generated for the Scientific Symposium and decrease in membership and actual expenditure was Rs. 22,32,600.

### Income

This year sees the continued patronage of COMOS members and the membership fees generated an overall income of Rs. 11,09,000, which forms the majority of the income.

This year saw institutional collaborations to support regional events and projects. Notably, collaboration with Dr. MCR HRD Institute of Telangana, Hyderabad to conduct the AGM 2023.

### **Expenditure**

Key expenditure has been focused on running of the secretariat - which is the backbone of the organization - and professional fees for annual consultancies.

- Rs. 50,000 which were brought forward to the Budget of FY 2023-24 for further advances to the official website has not been put to use and from that Rs. 20,000 is being brought forward to the Budget of FY 2024-25 for further advances.
- Three projects which were awarded support for NSC-led research in 2021 made progress in the year, with one undergoing expenses for work. All three projects were provided an extension of 6 months only for the upcoming financial year with remaining monies allocated for the projects being brought forward to the Budget of FY 2024-25.

### **Statutory Compliances**

All statutory compliances including, Filing of TDS and GST Returns for this FY, and filing of IT Returns of the previous FY, have been met.

# FISCAL PLANNING: FINANCIAL YEAR 2024-25

The Annual Budget for financial year 2024-2025 provides a framework for a bouquet of items of expenditure up to an amount of Rs. 39,07,775 though no more than 2/3rds of the budget may be used, unless external funding is received for expenses beyond that. This is to ensure that the annual deficit is maintained to a minimum, since the income anticipated to be generated is Rs. 22,27,000. This follows the same principle of financial management followed in the past financial years of the triennium.

The major source of income, as evidenced by previous years, continues to be expected to be generated through collection of annual membership fees and registrations from the annual scientific symposium. The annual bank interest is anticipated to contribute to up to 10% of the income (or Rs.2,07,000 lakhs), and should be maintained at this threshold, at the very least. Another 20% of the income (or up to Rs.5 lakhs) should be generated through collaborative activities with other Institutions to support research projects, training and outreach activities, as well as, through donations to the corpus of COMOS for its sustained existence and work. Fundraising and developing partnerships will be essential to achieve this target.

Expenditure is proposed under two core heads - A: COMOS Secretariat, and B: Research, Advocacy, Capacity Building and Outreach - amounting to Rs. 23,24,145 and Rs. 13,91,750 respectively (excluding GST).

Running of the COMOS Secretariat, includes office expenses, salaries and consultancies. Almost a quarter of the expenditure under this head is allocated for transfer to the ICOMOS International Secretariat as membership dues.

Expenditure towards Research, Advocacy, Capacity Building and Outreach, takes into account expenditure within the core institutional structures of ICOMOS India - its Zones, NSCs, EPWG and Working Groups - and builds from allocations in past budgets.

Costs towards digital platforms - such as a zoom subscription and associated add-ons, in addition to monies for maintenance and upgrades to ICOMOS India's official website - form the backbone to support communication within the organization and with the public as the core means of outreach.

Financial support to research projects led by NSCs has been extended for 6 months till September 2024 only. The projects are to be completed within this extended period, after which the amount will be forfeited.

Funding allocated for four E-publications has been brought forward from the budgets of the past three years. Monies for two more possible E-publications also finds place in this year's budget.
