Sacred Pillars of Goa

The sacred pillar, crafted in local wood and adorned with distinctive iconography is an essential feature in the Wooden temples of Goa. The sacred pillar called as 'Prasad Stambha or Prasad Khambo' is used to communicate with divinity through a ritual called 'Prasad Pakali' or 'Kaul', wherein the wish of divinity or guidance is sought by the community. The pillar crafted from local wood with sixteen-faced kumbha (sacrificial pot) and Nagas in Bodhika (brackets) , has immense religious significance and is an important architectural & cultural heritage of the region.

BUILDING REGIONAL COOPERATION THROUGH SHARED CULTURAL HERITAGE OF KOLKATA AND DHAKA


flourished during the Mughal period and Calcutta (present day capital of West Bengal), a colonial city. The riverine linkages, economic activities and historical contexts of both cities were highlighted. Furthermore, riverfront activity along the Buriganga and Hugli rivers were also pointed out. Ghats such as Sadar Ghat, Badamtali Ghat, Balur Ghat in Dhaka and the Hugly river Ghats shared similar economic activities once upon a time. However, less activity is noticed along the Hugli River as compared to the Buriganga in the contemporary period. Now Calcutta has turned its back on the river but not Dhaka. This is a major point of difference between the two cities.

The speaker, Ms. Kamalika Bose then went on to talk about the multi-ethnic character, the historic neighborhoods and community linkages of both cities. She highlighted how markets were at the core of their historic fabric and evolution. She further touched upon the trade-based river heritage project that she had undertaken with students.



COMPREHENSIVE STUDY OF VERNACULAR ARCHITECTURE AND HERITAGE SETTLEMENTS IN PUNJAB

19, 21, 29 February 2024, 1 to 5th March 2024

ICOMOS India conducted an activity, 'Comprehensive Study of Vernacular Architecture and Heritage Settlements in Punjab' in collaboration with the University Institute of Architecture, Chandigarh University.

Aligned with the ICOMOS India Training and Capacity Building program, the activity has been proposed by Dr. Niyati Jigyasu, Coordinator of NSC Historic Cities, Towns, and Villages, and supported by Dr. Vaishali Latkar, NSC Education and Training. This activity aimed to explore the vernacular architecture and settlements with ecological and historic contexts. The documentation workshop was planned in 3 stages that involved pre-activity webinars followed by an on-site study, and a review session concluding with a post-event session. The pre-activity lectures were conducted by experts from ICOMOS India and CU, covering topics such as methodology for documentation of tangible-intangible heritage, as well as application of geospatial technology in heritage study. The participants included 30 students from Architecture and 5 from Media Studies. The workshop also introduced students to contemporary documentation techniques such as photogrammetry and drone usage. The workshop concluded with a presentation of the student's final work to an audience comprising school children and community stakeholders.

The workshop is the second in a series of collaborative training programs put forth by the NSC HTV.

The workshop was held at the School of Planning and Architecture, Delhi on 18th March 2024 from 9.30 am to 1.30 pm in hybrid mode.





DR. M. SATISH KUMAR



Publications by ICOMOS India Member

ICOMOS India member, Dr. M. Satish Kumar, FRGS, FHEA, RCS, is a globally recognised interdisciplinary scholar, in the field of colonial, postcolonial and decolonial geographies of South Asia. Dr. Kumar was the former Director of Queen's Academy India and led the internationalisation initiative for Queen's and India from 2006-2014.

He is a Fellow of the Senator George J Mitchell Institute for Global Peace, Security and Justice, Queen's University Belfast. He is also a Fellow of the Royal Geographical Society, a Fellow of the Higher Education Academy, a Member of the Royal Commonwealth Society and one of the 6 Global Overseas Research Fellows at the Institute of Oriental Philosophy, Japan. With over 33 years of experience in Higher Education, Dr. Kumar has worked at Jawaharlal Nehru University, New Delhi, the University of Cambridge, and now at Queen's University Belfast.

He is the Chairperson for the Kerala Urban Policy Commission, 2023 and holds the Techno-India-Distinguished Honorary Chair of Global Sustainable Development Goals, Kolkata.

He is extensively involved in the academic community as a Panel Member of the UK Peer Review Colleges for Arts and Humanities Research Council (AHRC-GCRF). Member, Panel of Experts for Collaborative Research Action (CRA) Climate and Cultural Heritage- JPI Climate, JPI Cultural Heritage and the Belmont Forum (2023). Member, Editorial Board for Humanities & Social Sciences Communications, Springer Nature, 2023. He held Visiting Professorships at Banaras Hindu University, Jawaharlal Nehru University, Calcutta University, and the Soka University of America.

He was awarded the Belfast Ambassador Medal (2020); the Queen's University Student Nominated Teaching Award (2014) and the Bhoovigyan (Earth Scientist Award, 2002)-India.

He has secured significant research grants and contributed seminal interdisciplinary research outputs across various disciplines and in international journals. i.e., Annals of the Association of American Geographers, Journal of Historical Geography, and Journal of Asian Studies, among others.
