NSC RISK PREPAREDNESS



The event includes a talk by a committee member- expert as well as emerging professionals-on any topic related to risk preparedness of cultural heritage. It is followed by a closed monthly meeting between the members to reflect on the talk and to deliberate on future steps of the NSC. The event is hosted by NSC RP Coordinator Priyanka Panjwani and Co-Coordinator Shahzad A. Malik.

NSC RP CultuRisk Tech Talk #5 8 January 2022

The speaker for CultuRisk Tech-Talk #5 is Ar. Swapna Kothari, a practicing conservation architect, site preservation professional and an advocate for the built environment and traditions. With over seven years of experience, Swapna is also an educator and her key research engages in the use and evolution of buildings and how institutions (cross-culturally) aid each other with their conservation tools and theory.

In this talk, Swapna introduces the topic of 'antiquity theft' that poses a grave risk to cultural heritage around the world. She explores possibilities being carried out in other countries to mitigate theft, and discusses the scenario of white-collar theft, complex crime networks and repatriation in India.

NSC RP CultuRisk Tech Talk # 6 12 February 2022

The speaker for CultuRisk Tech-Talk #6 is Ar. Mohona Chakraburtty, an architect from India with a master's degree in architectural conservation. She has been working on ICCROM's "First Aid and Resilience for Cultural Heritage in Times of Crisis" program (FAR) since 2020. She has contributed to the development of several resources on community-based disaster risk reduction, peacebuilding tools, simulation exercises and safeguarding of cultural heritage during COVID-19.

In this talk, Mohona shares ideas of integration in the design, conservation and disaster management fields through walkthroughs and space visualizations. She highlights the need for designing scenarios in disaster management and risk preparedness through her talk titled, 'Disaster risk preparedness for cultural heritage through a graphical approach - my journey and realization'.

as a Conservation Laboratory in-charge at CEPT University and Research Associate at Center for Heritage Conservation.

In her talk, Nigar brings focus towards narratives that counter the Ahmedabad city's dominant world heritage narrative. Through the case study of Tankshal ni Pol Masjid, Nigar explores counter spaces within site schools that give a voice to the marginalized histories of communal violence, segregation, and women's access to praying spaces.



Collaborative Activities

WEST ZONE AND NSC - HTV

ICOMOS India Training and Capacity Building Program in collaboration with SMEF'S BRICK School of Architecture

4 & 5 January 2022

The activity "Comprehensive Study of Heritage Settlements in the Western Ghats" was proposed by Ar. Poonam Trambadia, West Zone Representative, Ar. Niyati Jigyasu, NSC HTV Coordinator and supported by NSC CL, NSC

Education and Training, and EPWG. This activity aimed to explore the nature-culture relationship through the study of vernacular architecture and settlements in relation to ecological & historic contexts. The activity was planned in 3 stages that include: pre-activity webinars followed by an on-site study, a review session concluding with a post-event session, and output in form of publication.

The area of study is situated in the Tillari region of the Western Ghats, one of eight bio-diverse hotspots in the world. The workshop was aimed at enhancing students' knowledge in settlements rich in living and cultural heritage. The study added to their understanding of tangible and intangible heritage within the context of symbiotic relations of ecology and communities.

The site visit was led by Dr Vaidehi Lavand, Coordinator of the activity and NSC HTV member. This will lead to a guidance document on undertaking studies in the context of historic settlements in such regions.

The activity included 3 days of preparatory sessions and 4 days of on-site study. While the first part was held on 29th Dec 2021, the second part took place on 4 - 5 January 2022.

On 4th January, Ms Saili Palande Datar and Dr Vaidehi Lavand covered topics on the association of cultural heritage and communities in Konkan and understanding settlement patterns in the Western Ghats. This session was part of the classroom lectures. On the same day the online webinar included talks by Ar. Suryanarayan Murthy on 'Introduction to the concept of Cultural Landscape in the Indian Context'.

Landscape architect Onkar Khebudkar gave a lecture on Tillari bioregion: Mapping Conflict of Man and Nature. These inputs were planned to establish the context of the study and make students aware of the study area. The session began with the introduction of ICOMOS India and NSC HTV by Ar. Niyati Jigyasu. This was followed by the introduction of West Zone by Ar. Poonam Trambadia.

The session on 5th January had inputs focusing on documentation methods. The offline talks were taken by Ar. Bhagyashree Bandekar and Aryan Salvi (4th Year B. Arch student) on methods of graphical documentation and sharing experience of settlement study.

The online session consisted of 3 experts, Dr Vaishali Latkar, Ar. Saranya Darshini and Ar. Ramiya G. While Dr Latkar gave a very detailed lecture on exploring methods for documenting tangible and intangible heritage,

Ar. Dharshini discussed the importance of the documentation process. Ar. Ramiya explained the inventory format for the onsite study. All these inputs helped students in the collection of data and putting it in graphical and text formats. The sessions from both days were summarized by Ar. Poonam Trambadia.

field visit was undertaken from 7-10 January 2022. Total three wadis i.e. Kudasewadi, Vanoshiwadi, and Deomalawadi were documented. Parts of Kudasewadi, namely Jadhaowadi and Gaothanwadi, were studied and documented. The students were divided into groups of 15-16 students.

The study included mapping clusters in detail, filling inventories and measured drawing of 3 to 5 houses per wadi. Compilation of data is in progress and options for publication formats are made.

Framework for publication would be given to the students based upon the data they collected and aiming at addressing the nature-culture journey.

Discourse towards Adequate Legal Framework for India's Heritage Protection


25 January 2022

News from Working Groups

EMERGING PROFESSIONALS WORKING GROUP (EPWG)

Master Plan for ICOMOS India: Heritage in India @ 75 years

March 2022

EPWG

With the Republic of India turning 75, the EPWG ICOMOS India prepared a Master Plan to develop a range of activities within the narrative of Heritage in India @ 75 years. All Zones, NSCs, WGs, and Institutional Members are invited to plan activities for the next two years as part of this triennium (2022–2023), which will contribute to the implementation of the Masterplan.

A multi-disciplinary task force is be established to develop the Masterplan and specific activities further in consultation with ExCom, Steering Committee, and respective Zone, NSC, WG, or Institutional Member. The Masterplan can be adopted by any Zonal Rep, NSC, WG, or Institutional Member to develop a joint collaborative activity within the framework of the Plan and a larger vision of Heritage in India @ 75.

There will be a requirement of funding and sponsorship in due course of time for multiple activities being proposed within the Masterplan framework, for which a proposal for a fundraising team along with the roadmap to achieve the required funding shall be initiated as per the activity, time schedule, delivery, and so forth. The number and profile of expected participants will vary as per each activity.

Furthermore, it is proposed that the resource persons and affiliations are to be invited from within and outside ICOMOS India as per the objectives, scope, and potential outcomes of the activity.

The proposal is for the overall ICOMOS India membership where each Zone, NSC, WG, and Institutional member can initiate and accomplish activities as per the milestones and narratives presented in the proposal. This Master Plan is intended to be a live document that can be adapted with time.

The Masterplan will be instrumental in addressing the seven key themes from the Strategic Plan (2020 – 2025) that will be Rights-Based Approaches in Heritage Management, Safeguarding Heritage@Risk, Nature Culture Journey, Development in Historic Cities / Smart Cities (or rural areas), Water and Heritage, Climate Change & Heritage, and Heritage & Resilience: Recovery from Pandemic & Human Crisis.

The Masterplan Narrative will be critical in proposing and driving the activities to achieve the mentioned goals and objectives. The activities are proposed to address the following components of the Masterplan narrative:

- 1. New Republic but an Ancient Country (Nation Building Momentum)
- 2. Conservation Uninterpreted Before and After Colonisation (Journey from

Regional Scriptures to International Charters)

- 3. Colonised Conservation (Emergence of ASI, Marshall Manual etc.)
- 4. Conservation School of Thought (Emergence of SPA, CEPT, returning students from York, ICCROM, new emerging professionals)
- 5. Heritage in the Aught (Next generation of Conservation Professionals, hits and misses)
- 6. Heritage Now- Us, our ideas and vision, redevelopment galore, guidelines for heritage in new perspective, too many colleges and not enough jobs, activate funding for future, heritage in conflict, role of social media and new tech etc.
- 7. Heritage in the Future @ 100 (SDG 2030, Climate Change, more regional approaches, Mars exploration, opportunity for conservation professionals archaeologists, placement)

The Masterplan is intended as a planning document that may be used to develop specific activities in order to reflect, assess, and strategize the programs of ICOMOS India in short, medium, and long terms.

Research on 'Heritage at Risk' initiatives supported by ICOMOS International

Optimising ICOMOS' 'Heritage at Risk' Initiatives:

Towards a Comprehensive Framework for
Cultural Heritage at Risk

ICOMOS India member Ms. Jayashree Bardhan's master's thesis on ICOMOS' 'Heritage at Risk' initiatives has been published and released on 23rd March 2022, by a joint initiative of ICOMOS International and the World Heritage Studies Programme of Brandenburg University of Technology (BTU) Cottbus-Senftenberg, Germany. The master's thesis is titled – Optimising ICOMOS' 'Heritage at Risk' Initiatives: Towards a Comprehensive Framework for Cultural Heritage at Risk. The publication is available here.

The research is part of ICOMOS' efforts for collaboration between ICOMOS and universities. The initial proposal for this research was submitted in response to ICOMOS' call for proposals published in January 2020. The rationale of the call and the need for the study was presented at the Scientific Council Meeting of ICOMOS held in Marrakesh in October 2019. The research, as mentioned in the call for proposals, was planned and designed to be integrated into the master's thesis of the researcher.

During the preliminary research for ICOMOS over a period of five months between April to August 2020, the researcher was mentored by a task team of the ICOMOS International Board (Ms. Teresa Patricio, Ms. Clara Mr.Rellensmann, Zeynep Gül Ünal, Riin Alatalu, Mr. Rohit Jigyasu, Mr. Mario Santana) and the International Scientific Committee on Risk Preparedness (Chris Marrion).

The preliminary report submitted to ICOMOS was titled - Analyzing the Effectiveness of the 'Heritage at Risk' Initiatives of ICOMOS and Developing Ideas for a Comprehensive Framework for Cultural Heritage at Risk. The preliminary report is available here.

The master's thesis submitted to BTU Cottbus-Senftenberg was mentored by Alexandra Skedzuhn-Safir and Clara Rellensmann.

20 years after ICOMOS's first attempts to initiate one of the first 'Heritage at Risk' programmes, this research was aimed at re-examining and analysing the effectiveness of ICOMOS' 'Heritage at Risk' programme within the current organisational/ institutional landscape of initiatives in the field of heritage at risk, that ICOMOS is embedded in.

It was also an opportunity to situate the programme within the diverse views of the heritage at risk framework and the continuing shifts in the foundational paradigms of the international discourse on heritage conservation.

The purpose of this analysis was to guide programme improvement for optimising efforts in favour of cultural heritage at risk within and/ or beyond ICOMOS and improve their ability to contribute towards safeguarding heritage at risk, increasing the resilience of cultural heritage and sustainable development.

The findings of the research have been presented in several ICOMOS forums. As one of the first follow-ups to this research, ICOMOS International in collaboration with Estonian Academy of Arts' (EKA) Cultural Heritage & Conservation Department conducted a weeklong Global inter-university summer-school on 'Heritage Alert and Advocacy'.

Ms. Jayashree's research was one of the key presentations in the summer school. This summer school was designed to actively engage students and emerging professionals in the preparation of heritage alerts and recognising the threat to heritage as a global phenomenon. Cultural Heritage and Changing Dynamics of Economic Development amidst the Blow of Covid 19 and Climate Change



Ms. Priyanka Panjwani, Coordinator of ICOMOS India National Scientific Committee on Risk Preparedness was invited to speak at the ResiliArt Debate, which is part of a series of discussions that will fuel ICOMOS' additional recommendations for cultural policies at the UNESCO World Conference on Cultural Policies and Sustainable Development - MONDIACULT 2022.

The interaction of cultural heritage and the ever-changing global economic development landscape is critical for survival during and recovery after a pandemic, especially with climate change as an added challenge. Ms. Priyanka responded to the five discussion questions while keeping in mind the policies and systems for post-pandemic cultural recovery in the Indian context.

Through these discussions, ICOMOS promotes the development of strategies for how heritage sites and landscapes can respond to global challenges, as well as informing various stakeholders about the positive role of heritage in employment and welfare, as well as revealing the value of culture in building a more resilient and sustainable future for our planet.

Climate Change Awareness Champion

The National Institute of Urban Affairs' Climate Centre for Cities (C-Cube) was established in June 2021 as part of India's Ministry of Housing and Urban Affairs Smart Cities Mission. Sankari Sahitya Sanskriti Award to Dr. Sanjib Kumar Borkakoti

Jorhat Sahitya Sabha honored Dr Sanjib Kumar Borkakoti with Sankari Sahitya Sanskriti Award on 6th March 2022 in a solemn function. Jorhat Sahitya Sabha is the Jorhat district unit of Asom Sahitya Sabha, the premier literary body of Assam. Sankari Sahitya Sanskriti Award was newly constituted by them and Dr Sanjib Kumar Borkakoti was the first recipient. It was in recognition of his dedicated and extensive work in promoting the literary and cultural contributions of Srimanta Sankaradeva in 2021.

The award function was chaired by Dr Ratul Chandra Bora, former registrar of Mahapurusha Srimanta Sankaradeva Vishwavidyalaya. He had created a trust named Dr Ratul Chandra Bora Sankari Sahitya Sanskriti Trust, which would be managing the award. The meeting was also attended by Dr Basanta Goswami, former secretary of Asom Sahitya Sabha, Dr Jyotirekha Hazarika, Dr Binita Dutta etc. Mr.Rajanikanta Dutta, former chairman of Srimanta Sankaradeva Sangha inaugurated the event. They all appreciated the works of Dr Borkakoti in the field of literature and culture. His activities in the International Committee of Intangible Cultural Heritage, ICOMOS was also mentioned.

Dr Sanjib Kumar Borkakoti said in his acceptance address that the ambit of Srimanta Sankaradeva's activities covered a large part of North India. He was the founder of a new classical dance named Sattriya dance as well as new classical music Bargeet. The saint was the first playwright in all modern Indian languages with his Ankiya plays.

The citation referred to 57 books authored by Dr Sanjib Kumar Borkakoti and lauded his promotion of the Sankari literature and culture globally. He delivered lectures on life and works of the medieval reformer litterateur in different universities in and outside India. This was also mentioned in the citation. His contribution in the establishment of Mahapurusha Srimanta Sankaradeva Vishwavidyalaya was also appreciated.
